

GCADA Names New Board of Directors for 2011

Cleveland, OH (December 14, 2010) —The Greater Cleveland Automobile Dealers' Association (GCADA) has named a new board of directors for 2011. The announcement was made by Louis A. Vitantonio, Jr., President of the GCADA, at the organization's 44th Annual Reception.

"It's been a great year working with Lou Vitantonio and the Association," said Burke. "The Association has new leadership that is poised to meet the challenges of the future."

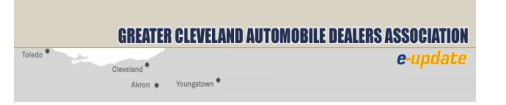
