

Cleveland, OH (December 6, 2011)—Think your classic car has what it takes to out distance the competition in terms of style, class and grace? Well now you have the chance to prove it.

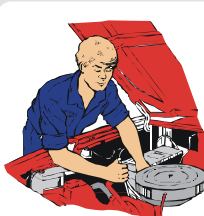
