She is also a member of the House Small Business Committee, where she is leading the Contracting and Workforce Subcommittee as the Ranking Democrat and serves on the Economic Growth, Tax and Capital Access and Agriculture, Energy and Trade Subcommittees. lenge and greatest opportunity is the education of our children. While there has been progress, it is not enough and too many of our children are being left behind in failing schools.

In response to this challenge, we have developed The Cleveland Plan. It addresses the fiscal crisis in the district and dramatically improves educational opportunities for our children. I instructed Eric Gordon, the Chief Executive Officer of the Cleveland Metropolitan School District, to work in partnership with the Greater Cleveland Partnership, the Cleveland Foundation, The Gund Foundation, and The Breakthrough Charter Schools, to develop this plan. You can read the full plan here.

We examined local and national reform movements and are confident that The Cleveland Plan draws upon the best practices and can be implemented in Cleveland with great results. Elements of the plan are summarized below:

· The Cleveland Municipal School District (CMSD) will adopt

a portfolio strategy, transforming from a

Cleveland's greatest chal- traditional, centrally directed system to a diverse portfolio of schools. It will include high-performing district schools as well as high performing district-sponsored charter

> · CMSD's central office will provide certain services and management of the portfolio of schools, but allow greater autonomy to those that have a proven record of success. Low performing schools will be guided by aggressive intervention plans.

> Money will be allocated to schools and classrooms in a per-pupil funding system, allowing those schools that have earned more autonomy to make the best spending decisions for their schools. Voters will be asked to approve a property tax levy that benefits the entire portfolio of

> This innovative plan has the support of a broad range of stakeholders including the school district's CEO and school board, and leaders from the business, foundation and charter school communities. In order for us to be successful, we must have the right policy conditions in place. These conditions include: necessary changes in state policy, a fresh start in labor-management agreements and relationships, and a financial sustainability plan. The necessary changes in state policy are particularly important, as they become the framework for new labor-management agreements and a

sustainable financial position for the district. This evening, CEO Gordon and I met with members of our state delegation and the Cleveland Teachers Union to discuss the plan and we will continue our conversations with them in the near future.

We are faced with very difficult decisions. However, they become less difficult if we keep in mind that these are our children and this is our future. We simply cannot continue to hold children hostage to a system that is failing them. We must seize this opportunity to reinvent public education in Cleveland


