She immediately got to work representing the interests of her constituents, voting on several environmental bills and working through the night on her first day in office, during a marathon debate on im-

Cleveland's Innovative Plan for Reinventing Education



Cleveland's greatest challenge and greatest opportunity is the education of our children. While there has been progress, it is not enough and too many of our children are being left behind in failing schools.

In response to this challenge, we have developed The Cleveland Plan. It addresses the fiscal crisis in the district and dramatically improves educational opportunities for our children. I instructed Eric Gordon, the Chief Executive Officer of the Cleveland Metropolitan School District, to work in partnership with the Greater Cleveland Partnership, the Cleveland Foundation, The Gund Foundation, and The Breakthrough Charter Schools, to develop this plan. You can read the full plan here.

We examined local and national reform movements and are confident that The Cleveland Plan draws upon the best practices and can be implemented in Cleveland with great results. Elements of the plan are summarized below:

- The Cleveland Municipal School District (CMSD) will adopt a portfolio strategy, transforming from a

traditional, centrally directed system to a diverse portfolio of schools. It will include high-performing district schools as well as high performing district-sponsored charter schools.

- CMSD's central office will provide certain services and management of the portfolio of schools, but allow greater autonomy to those that have a proven record of success. Low performing schools will be guided by aggressive intervention plans.

- Money will be allocated to schools and classrooms in a per-pupil funding system, allowing those schools that have earned more autonomy to make the best spending decisions for their schools. Voters will be asked to approve a property tax levy that benefits the entire portfolio of schools.

This innovative plan has the support of a broad range of stakeholders including the school district's CEO and school board, and leaders from the business, foundation and charter school communities. In order for us to be successful, we must have the right policy conditions in place. These conditions include: necessary changes in state policy, a fresh start in labor-management agreements and relationships, and a financial sustainability plan. The necessary changes in state policy are particularly important, as they become the framework for new labor-management agreements and a

sustainable financial position for the district. This evening, CEO Gordon and I met with members of our state delegation and the Cleveland Teachers Union to discuss the plan and we will continue our conversations with them in the near future.

We are faced with very difficult decisions. However, they become less difficult if we keep in mind that these are our children and this is our future. We simply cannot continue to hold children hostage to a system that is failing them. We must seize this opportunity to reinvent public education in Cleveland.

- 奧巴馬總統姑媽遞解出境開案 2008 年 12 月申請, 2009 年 1 月獲准重審, 2010 年 5 月政府獲准, 2011 年 7 月 25 日申請 1-485, 2011 年 9 月 29 日獲准。
- 1. 夫妻年齡相差 20 歲, 公民先生曾婚 3 次, 太太廣州問題被拒後找到我們, 重新申請 130 兩個月批准, 又三個月後廣州問題通過。
- 2. 太太政治庇護 2005 年獲批後兩年內未幫先生申請 1-730, 2010 年申請和上訴均被拒, 2011 年 6 月重新申請 10 月批准。
- 3. 中國記者申請政治庇護, 紐約移民局問話獲批准, 前後歷時兩個月。
- 4. 太太 94 年自動離境, 95 年偷渡回美, 先生偷渡有 1-94 還有犯罪記錄, 用太太的公民父親 130 申請夫妻倆人綠卡, 太太 6 個月獲批准, 先生 9 個月獲批准。
- 5. 先生用假護照入境被拒, 用公民太太申請綠卡, 1-485 問話後申請 601 豁免, 僅 20 天批准並獲綠卡。
- 6. 留學生意外懷孕, 與先生有一個孩子在國內, 申請政治庇護, 兩個月獲批准。
- 7. 太太入境有 1-94, 公民先生申請綠卡, 被移民局拒, 申請 1-485 開案, 兩個月批准後再問話獲准。
- 8. 某先生輸了庇護申請上訴也遭拒絕後他聘請我們為他的庇護重新開案, 2011 年 5 月開案成功。
- 9. 我們的客戶是緬甸公民, 他輸掉了他的庇護申請案, 提出上訴申請也遭到拒絕, 他聘請我們黃唯律師樓, 為他的庇護重新開案。在美國法規基礎上我們準備了詳細的議案, 並提交證明文件, 2011 年 5 月移民上訴委員會接受重新開案, 案件被重新送回移民法庭, 使我們的客戶可以繼續他的庇護申請。
