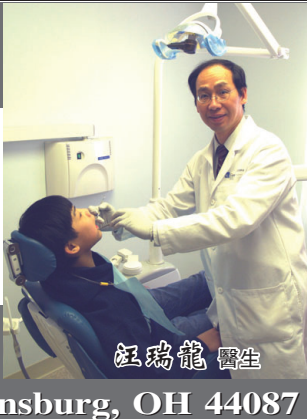

Cleveland, OH (June 11, 2012) - Want to know more about immigrants who changed the face of Northeast Ohio, wander back through time surrounded by precious artifacts from ancient lands, learn about the Cleveland roots of Superman and Jesse Owens, guess the birth names of stars like Bob Dylan, Jason Alexander or Ann Landers?
