

Family Wins Asylum, Misses Children

(New York, NY - March 28, 2014) William Low, Esq., attorney-in-charge of the Margaret W. Wong & Associates, Co., LPA, New York office and seasoned immigration attorney, told his clients on Tuesday, March 25th, the long-awaited news that after five years of fleeing persecution and suffering detention by US immigration authorities, they were legal in the US.

"But what of our children?" the wife immediately asked.

In August 2010, the man and his wife, who were born Buddhist, but lived as atheists in their Asian home country, were denied a license to sell their produce, because of their race and being non-Muslim. Fearing their lives were in danger, the couple arranged for their children to remain with relatives, and the two began a perilous journey.

Crossing oceans and deserts they reached the US. Once in the US, they were detained and jailed by the Department of Homeland Security's Immigrations and Customs Enforcement (ICE). And being jailed in the US was the best thing that ever happened to them.

Inside immigration detention, separately, the husband in the men's section, and the wife in the women's section, they were introduced to Christianity.

"In the summer of 2010, after leaving detention in Texas," William Low said, "these two began attending church regularly, were

soon baptized, and were actively engaged in the Christian faith that included spreading the gospel and other volunteer work at the church. But their children never left their minds. They soon hired our firm to help move their cases from Texas to New York and with their asylum cases."

"Of course, almost daily, they asked us about the children. When could they see them? When could they bring them to the US? This separation from their children has been very difficult on them - they can think only of their children."

William Low and the firm encountered challenge after challenge. But working closely with the couple, they succeeded in having the couple's two cases consolidated, and finally won the case.

"So, naturally," said William Low, "as soon as we gave them the news Tuesday, they begged us to bring their children to the US. We've immediately refocused on getting the children as soon as possible, preparing the I-730 petitions. We're confident it won't be much longer."

College student from Cleveland studying in Shanghai singled out by Michelle Obama: Higher Education Roundup

CLEVELAND, Ohio - A Cleveland student studying at New York University's campus in Shanghai was pointed out by Michelle Obama on the First Lady's trip to China.

Royale Nicholson, who graduated from John Hay Early College, enrolled last fall in the inaugural class at New York University Shanghai.

"I was filling out the application for NYU, and I saw there was an option for a Shanghai campus," she said in an interview last year. She received a scholarship that covered all her costs.

Half of the 300 students at NYU Shanghai are Chinese, a third are American, and the rest come from 33 other countries, the university said.

Obama, whose weeklong trip ended Wednesday, spoke about the importance of education to a group of Chinese and American students in Beijing on March 22.

She highlighted how education promoted cross-cultural understanding and communication necessary to confront global challenges.

"Studying abroad isn't just a fun way to spend a semester; it is quickly becoming the key to success in our global economy," she said.

Obama focused on several students in the audience. She recognized a Chinese scholar who had studied in the United States, as well as several American students who chose to study in China, including Nicholson.

"Take the example of Royale Nicholson, who's from Cleveland, Ohio," Obama said. "She attends New York University's program in Shanghai. Now, like me, Royale is a first-generation college student. And her mother worked two full-time jobs while her father worked nights to support their family. And of her experience in Shanghai, Royale said -- and this is her quote -- she said, 'This city oozes persistence and inspires me to accomplish all that I can.'"

The university said Nicholson said she hoped her "unexpected path to NYU Shanghai can encourage others in my school and my city to believe that their dreams don't have to be confined to the state that they've lived in their entire lives. They should not define or suppress their dreams because of their level of income. I know how easy it can be to slip into the illusion of inferiority. It is just amazing to me -- being able to see the dreams of people of China being realized in Shanghai literally overnight."

● 來自佛羅里達州的陳小姐于2011年3月找到我們黃唯律師事務所, 想要辦理綠卡。陳小姐回憶自己曾在2001年4月申請了勞工紙, 所以持有245(i), 可以在美國直接調整身份。
 我們的律師很快地幫陳小姐向勞工部和移民局調取相關材料。遺憾地是, 根據勞工部的規定, 凡自申請終止之日起5年後的材料將自動銷毀, 陳小姐當年材料已無法找到。但律師並沒有放棄。經過和州地方勞工部辦公室的多次交涉, 我們終於在2013年1月獲得了該辦公室對陳小姐當年申請的認可。陳小姐終於得到了證明其持有245(i)的證明。律師隨後為陳小姐準備了綠卡申請的材料, 並於2月為陳小姐遞交了申請。陳小姐于5月份收到了c9卡。在律師的陪同下, 陳小姐在7月份參加綠卡的面談, 並於8月收到了485申請的獲批通知, 成功地收到了綠卡。
 ● 黃先生持旅遊簽證來美後逾期居留。黃先生的女兒是美國公民, 想要為黃先生申請綠卡。本案的難點在於, 黃先生在其結婚證和女兒的出生證上的名字和其自己出生公證、護照以及i-94卡上的名字並不一致, 這就造成了無法證實父女關係和造假的嫌疑。除此之外, 黃先生因行為不檢, 在美國留下了犯罪記錄。我們的律師為黃先生調取了相關材料, 確認了所有文件上的姓名。在綠卡申請材料上, 律師決定不使用黃先生的結婚證而改用其他相關證據來證明其父女關係, 以避免不必要的駁回申請。律師在2012年8月為黃先生遞交了綠卡申請。同年11月, 黃先生收到了c9卡。
