

Cuyahoga Arts & Culture Now Accepting Applications for Funding in 2015

Grants Available for 501c3 Nonprofits Presenting Arts and Cultural Programming in Cuyahoga County

CLEVELAND (May 20, 2014) – Cuyahoga Arts & Culture (CAC) encourages 501c3 nonprofit organizations offering arts and cultural programming in Cuyahoga County to apply for funding in 2015 through its General Operating Support or Project Support grant programs.

CAC is now accepting applications to the following grant programs:

- General Operating Support provides two years of unrestricted, core support for Cuyahoga County-based 501c3 nonprofit organizations that have a primary mission of arts or culture. Grant size is determined by formula.

- Project Support I offers grants of up to \$50,000 for 501c3 nonprofit organizations presenting arts or cultural projects in Cuyahoga County in 2015.

- Project Support II offers grants of up to \$5,000 for 501c3 nonprofit organizations presenting arts or cultural projects in Cuyahoga County in 2015.

The Eligibility Check, the first step in the application process, is due Wednesday, June 25, 2014 by 4:30 pm. If eligible, an organization may submit an application, which is due Thursday, August 28, 2014 by 4:30 pm. Organizations may only apply to one grant program.

"Since 2007, Cuyahoga Arts & Culture has invested \$112 million through nearly 1,000 grants to nonprofit organizations throughout Cuyahoga County, and we welcome organizations offering arts and culture programs to apply now for CAC grants in 2015," said Executive Director Karen

Gahl-Mills. "Our county is fortunate to have this source of public funding for arts and culture, which strengthens our community by making it a better place to live, work and play."

Cuyahoga Arts & Culture defines arts and culture broadly to include natural history and natural science, in addition to traditional "arts and culture." To see a list of our current Cultural Partners – our grantees – visit <http://cacgrants.org/who-we-support.php>.

• 來自弗羅里達州的陳小姐于 2011 年 3 月找到我們黃唯律師事務所,想要辦理綠卡。陳小姐回憶自己曾在 2001 年 4 月申請了勞工紙,所以持有 245(i),可以在美國直接調整身份。

我們的律師很快地幫陳小姐向勞工部和移民局調取相關材料。遺憾地是,根據勞工部的規定,凡自申請終止之日起 5 年後的材料將自動銷毀,陳小姐當年材料已無法找到。但律師並沒有放棄。經過和州地方勞工部辦公室的多次交涉,我們終於在 2013 年 1 月獲得了該辦公室對陳小姐當年申請的認可。陳小姐終于得到了證明其持有 245(i) 的證明。律師隨後為陳小姐準備了綠卡申請的材料,並于 2 月為陳小姐遞交了申請。陳小姐于 5 月份收到了 c9 卡。在律師的陪同下,陳

小姐在 7 月份參加綠卡的面談,並于 8 月收到了 485 申請的獲批通知,成功地收到了綠卡。

• 黃先生持旅遊簽證來美後逾期居留。黃先生的女兒是美國公民,想要為黃先生申請綠卡,本案的難點在於,黃先生在其結婚證和女兒的出生證上的名字和其在自己出生公證、護照以及 i-94 卡上的名字並不一致,這就造成了無法證實父女關係和造假的嫌疑。除此之外,黃先生因行爲不檢,在美國留下了犯罪記錄。我們的律師為首先為黃先生調取了相關材料,確認了所有文件上的姓名。在綠卡申請材料上,律師決定不使用黃先生的結婚證而改用其他相關證據來證明其父女關係,以避免不必要的豁免申請。律師在 2012 年 8 月為黃先生遞交了綠卡申請。同年 11 月,黃先生收到了 c9 卡。
