TO QUALIFY FOR THIS POSITION YOU MUST MEET ONE OF THE FOLLOWING:

To qualify based on education, you must have successfully completed a full 4-year course of study in any field leading to an undergraduate degree from an accredited college or university, or you possess an undergraduate degree in any field from an accredited college or university. If you qualify based on education, you must submit a copy of your official college transcripts with your application.

To qualify based on generalized experience, you must have three years of progressively responsible experience, one year of which is equivalent to the GS-4 grade level, and your experience must demonstrate that you possess the following: ability to analyze problems to identify significant factors, gather pertinent data and recognize solutions, plan and organize work, and communicate effectively orally and in writing.

The Department of Veterans Affairs, Cleveland Regional Office is recruiting for Veteran Service Representatives (VSR). The VSR is an advocate for VA claimants providing information about a broad range of benefits and assisting with applications for VA benefits and services. The VSR researches and gathers requisite evidence from medical, military, community, and other sources to support benefit determinations. Candidates must possess the following skills:

- 1. Ability to research, comprehend, interpret, and apply written procedures, guidelines, and regulations that apply to claims activities.
2. Ability to extract and analyze relevant data and information from official records and documents, including computer system records and applications.
3. Ability to accurately perform work requiring attention to detail.
4. Ability to communicate orally with people from a variety of backgrounds.
5. Ability to determine priorities and organize work to stay within prescribed time limits.

TO QUALIFY FOR THIS POSITION YOU MUST MEET ONE OF THE FOLLOWING:

To qualify based on education, applicants must have completed one full year of graduate level education or completed a full 4-year (120 credit hours) course of study leading to a bachelor's degree from an accredited college or university and meet the superior academic achievement criteria. Superior Academic Achievement is based on a GPA of 3.0 or higher out of a possible 4.0 ("B" or better) as recorded on the official transcript.

To qualify based on specialized experience, applicants must possess one-year of specialized experience equivalent to at least the GS-5 level or equivalent in Federal service. Specialized experience is experience that equipped the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled.

Veterans' Recruitment Appointment (VRA)

Qualified candidates are in receipt of a campaign badge for service during a war or in a campaign or expedition; OR are a disabled Veteran, OR are in receipt of an Armed Forces Service Medal for participation in a military operation, OR, are a recently separated Veteran (within the last 3 years), AND separated under honorable conditions (this means an honorable or general discharge), you are VRA eligible.

Schedule A

Qualified Candidates must have a disability that substantially limits one or more major life activities. To be eligible: The person must have a severe physical, cognitive, or emotional disability; have a history of having such a disability; or be perceived as having such disability. NOTE: If you are qualifying under this hiring authority you MUST submit a certification letter from a State Vocational Rehabilitation Office or the Department of Veterans Affairs, or a physician's statement indicating your disability along with your application/resume package.

2. DD214 (if applicable)

- 1. You must be a U.S. citizen to apply for this job.
2. Subject to a background/suitability investigation.
3. A complete application package: Resume, Veteran Preference (if apply), Transcripts.
4. Travel is required for training purposes.
5. Selective Service System registration for males born after 12/31/1959.
6. Must be able to communicate in English both oral and written.
