Case Western Reserve University and Taipei Medical University in Taiwan have formed a broad collaboration poised to include student and faculty

exchange programs and joint research efforts.

The three-year agreement calls for research collaborations focused on the institutions' strengths in the areas of cancer, brain sciences, biomedical engineering, medical device and drug development, and geriatrics and long-term care. As part of the agreement, each year, \$162,000 from Taipei and \$10,000 from Case Western Re-

serve will be pumped into a new research fund, which will support research at both institutions. Awards will be determined by a joint advisory board

"This collaboration represents yet another way that Case Western Reserve continues to advance the commitment we made to internationalization in our 2008 strategic plan," university president Barbara R. Snyder said in a statement.

"Taipei Medical University is an impressive university, and we look for ward to working even more actively with their faculty and students," Snyder said. "The greater our global engagement with other top institutions of higher education, the stronger our education and research programs will be."

The agreement also calls for faculty to work together on projects that offer commercialization opportunities.

The universities started exploring ways to collaborate about two years ago and since have participated in several exchange programs. Case's engineering program and Taipei have also collaborated on a dual master's degree in biomedical engineering.
