《世界日報》報道,在23日的"和 談"破裂之後,舊金山華裔業主吳 女士 (Jane Wu) 被六名租客索賠 1440 萬元(美元,下同)的案件 26 日被迫開庭審理,有上百位華裔小 區居民到場聲援吳女士。案件審理 從高等法院開門後開始進行,直至 傍晚關門時才叫停,代表租客的原 告律師提出各種問題嘗試讓吳女 士就範,法官則拒絕了這名律師部 分"無理"要求。

民衆紛紛穿上紅色 T 恤衫,貼 上"支持正義"的標籤在庭外集會, 撕下了標語後才進場聽審,隨即遭 到原告律師的控訴, 卻遭法官阻 止。法官認爲,民衆有權在法庭門 外穿上有任何標籤的衣服,只要不 帶進庭審現場。

原告律師提出,要求吳女士給 六名租客搬走後每人每月1500元 的房屋租賃費用,大約持續三年,相 當于吳女士每月需要支付這些租 客共計9000元。目前,這些租客租 住吳女士的房子,月租是750元,而 相同條件的房子當前在其他地方

中新網 3 月 28 日電 據美國 的市場價是每月 2250 元, 之間有 1500元的差額。對沒有正常收入 來源,且19個月沒能收到房租的 吳女士而言,這是一個無法接受的 "天價",法官對原告律師的這項要 求予以否決。

> 原告律師多次引用舊金山租 賃不動産條例 1942 條第 4 款的規 定,認爲吳女士沒有繼續收取租金 的權利。這一條款指出,如果物業 有危及生命健康和財産安全的情 况,業主沒有及時修理,業主不得要 求收租或加租。吳女士無奈地表 示,這些租客肆意破壞屋內設施,然 後去市府投訴她,又阻止她人內檢 查和修理,租客又接連不斷地以此 爲由不交租,已經讓她的經濟狀况 雪上加霜。

> 16人的陪審團有望在未來-兩天從 70 人中選出,其中 12 人出 庭,4人後備,案件審理預計持續兩 至三個星期。吳女士準備了很多顯 示租客惡意破壞房子的照片,呈交 給陪審團過目。原告律師卻認爲, 這些圖片對租客相當不利,不希望 吳女士在陪審團面前展示這些照 片,同時對吳女士和支持者在到場 採訪的六家華文媒體面前發表看 法表示不滿。
