### Introduction: China Finance & Industry Group

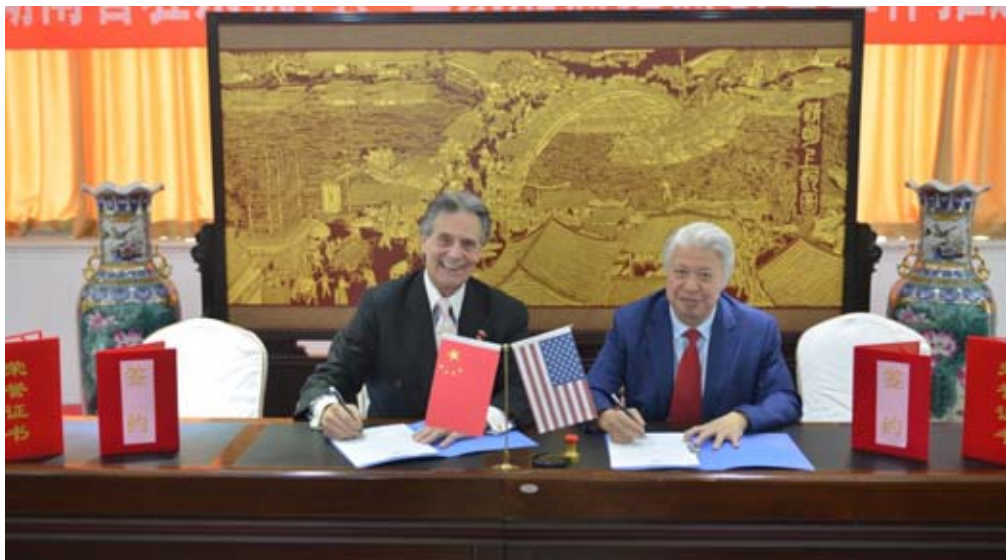
